

4LK Healthcare Gun Safety Protocol (Evidence-Based)

To prevent firearm-related injuries and deaths among children by incorporating gun safety counseling, education, and community advocacy into pediatric practice.

1. Background

- Firearm injuries are now the leading cause of death in children and adolescents in the U.S. (New England Journal of Medicine, 2022).
- 1 in 3 U.S. homes with children has a gun; 75% of these guns are stored unlocked (AAP, 2021).
- The risk of unintentional injury or death is 4x higher in homes with unlocked firearms.

2. Clinical Protocol

A. Screening (at Home Visits)

We will ask all families (confidentially and non-judgmentally):

- "Do you keep firearms in your home or vehicles?"
- If yes:
 - "Are they stored locked and unloaded?"
 - "Is the ammunition stored separately?"

B. Counseling

- Normalize the discussion:
 - "We ask all families this because firearm injuries are one of the top causes of harm in children."
- Emphasize safe storage:
 - Locked
 - o Unloaded
 - Ammunition stored separately
- Offer safety tips and written materials.

C. Provide Safety Devices

If possible, distribute or refer families to:

- Free or discounted gun locks or lockboxes
- Local police or health department programs

3. Family Education Materials

Provide handouts like:

- o AAP Firearm Safety Guidelines
- Project ChildSafe materials
- 4LK-branded "Home Safety Checklist"

5. Community and Advocacy

- Advocate for:
 - o Child Access Prevention (CAP) laws
 - o Firearm Injury Prevention Programs in schools
